

Cookies Policy

Our Website may use proprietary and third-party cookies to provide you with a better experience and service, based on your browsing habits.

Continuing to browse implies full acceptance of their use. You can find more information in our cookies policy.

A "cookie" is a small file that contains information about the user's browsing and is stored on the user's computer, tablet, smartphone or any other device. The set of cookies allows us to improve the quality of our website and informs us which websites our users find useful and which they do not.

Cookies are essential to the functioning of the internet, as they provide countless advantages for the provision of interactive services, thus facilitating the browsing and usability of our website. Please bear in mind that cookies cannot harm your device and that, in fact, having them active will help us to identify and solve errors.

Types.

The information below will help you to understand the different types of cookies:

- **Proprietary cookies:** these are sent to your computer from our own computers and domains that we use to provide the services you require from us.
- **Third-party cookies:** these are sent to your computer from a computer or domain that is not managed by us, but by a collaborating entity. For example, those used by social networks or by external content like Google Maps.
- **Session cookies:** these are temporary cookies that stay in the cookies file of your browser until you leave the website, which means that none of them are stored on your computer's hard drive. The data obtained through these cookies is used to analyse traffic patterns on the website. In the long term, this will allow us to provide a better experience by improving the content and making it more user-friendly.
- **Persistent cookies:** these are stored on your hard drive and our website reads them every time you visit us. A persistent cookie has a pre-set expiration date. The cookie will no longer work after said date. We usually use these cookies to facilitate registration services.
- **Technical cookies:** these are necessary for the navigation and proper functioning of our website. For instance, they allow us to monitor our traffic and communication of data, access restricted areas, use security elements, store content for videos or share content through social media.
- **Personalisation cookies:** these allow you to access our services with a pre-defined set of features according to a set of criteria, like for example language, the type of browser through which you are accessing the service, the local configuration from where you are accessing the service, etc.
- **Analysis cookies:** these allow us to quantify the number of users and therefore measure and carry out statistical analyses of the way our users interact with the services we provide. For this purpose, your browsing is analysed on our website with the aim of improving the range of products and services that we offer.
- **Advertising cookies:** these allow us to manage, in the simplest way possible way, the advertising space that could be included on our website.
- **Behavioural advertising cookies:** these cookies store data about the behaviour of users obtained through continued observation. With them, we can learn about internet browsing habits and show you advertisements that relate to your browsing profile.

Además, algunos Servicios pueden utilizar conectores con redes sociales tales como Facebook o Twitter. Furthermore, some Services may use social media connectors such as Facebook or Twitter. When a user registers for a Service using credentials from a social network, they authorise the social network to save a persistent cookie that will remember their identity and will grant them access to the Services until it expires.
