## **1. BASIC INFORMATION ON DATA PROTECTION**

Owner: GROM PLACE, S.L.

Purpose: Providing the requested services, maintaining communication in order to fulfil said services and keeping you informed on our activity in general.

Legitimacy: Execution of a contract. Consent of the interested party.

Recipients: Data will not be transferred to any third party, unless due to legal obligations.

Rights: You have the right to access, modify and delete your data, as well as other rights detailed in the additional information section, which you may exercise by writing to the address provided in said additional information section.

*Who is responsible for processing your data?*

*For what purpose are your personal data processed?*

At GROM PLACE, S.L., we process the data provided by interested persons with the aim of delivering the agreed services; performing the administrative, accounting and fiscal management associated with the requested services; maintaining communications related to said services; and sending notifications, including those via email, to keep you informed of our activity in general.

*How long will we store your data?*

Your data will not be deleted unless you request that we do so, and we will store your data for the required number of years to comply with our legal obligations.

*What is the legitimisation for the processing of your data?*

The processing of your data is based on the following legal grounds:

- The execution of a contract: providing the requested services
- Consent of the interested party: sending advertising communications about

our general activity.

*Who will we share your data with?*

Your data will not be shared with any third parties, unless due to legal obligations.

*Sharing of your data with other countries?*

We do not expect to transfer any data to other countries.

*What are your rights when you provide your data to us?*

All persons have the right to obtain confirmation of whether GROM PLACE, S.L. is processing personal data that concern them.

Said interested persons have the right to access their personal data and to request the modification of inaccurate data or, if they wish, to request the deletion of said data when, among other reasons, the data are no longer necessary for the purposes for which they were originally collected.

In certain circumstances, the interested parties may request that the processing of their data be limited, when this is the case we will only store said data for the purposes of conducting or defending ourselves against claims. Moreover, in the cases established by law, you will have the right to transfer your personal data.

In some specific circumstances and due to reasons related to their specific situation, said interested persons may oppose the processing of their data. In this case, GROM PLACE, S.L. will stop the processing of their data, except in the presence of compelling legitimate grounds, or for the purpose of conducting or defending against potential claims.

You may exercise your rights in the following ways:

If you have given your consent for any specific purposes, you have the right to withdraw said consent at any point, without this affecting the legality of the processing that was based on the consent given prior to its withdrawal.
